- ◆ **the financing of infrastructure**, where the Paris financial center has an unparalleled ecosystem of investors, intermediaries, infrastructure developers, lawyers and financial consultants, and significant experience in public-private partnerships;
- ◆ **innovation**, with both a dynamic fintech base and major players heavily investing in digital transformation; Finance Innovation, a branch of Paris Europlace, plays a central role in supporting young financial companies and in stimulating this kind of entrepreneurship.

Paris Europlace is chaired by **Augustin de Romanet**, Chairman and CEO of the ADP Group, with **Jean Lemierre**, Chairman of BNP Paribas, and **Yves Perrier**, Chairman of Amundi, as Vice-Chairmen.
